1. Applicants must fill information in the space provided on page one of the Registration document.
2. All applicants should clearly indicate on the envelope the category they are interested in. One document shall represent ONLY ONE category. For those interested in various categories, they should submit separate documents in the various categories.
3. The Registration Application should be prepared and submitted in a plain sealed envelope clearly marked: **EOI No** and Description and addressed to:

4. The closing date for submission of registration documents shall be on 20th August 2024 at 05.00 p.m. East African time. Any Registration document submitted after the deadline shall be automatically rejected.
5. Officers/Employees of the Procuring Entity, their Spouses, Child, Parent, Brothers or Sister. Child, Parent, Brother or Sister of a Spouse, their business associates or agents and firms/organizations in which they have a substantial or controlling interest shall not be eligible to be prequalified.
6. An Applicant that is a Kenyan firm or citizen shall provide evidence of having fulfilled his/her tax obligations by producing a current tax clearance certificate or tax exemption certificate issued by the Kenya Revenue Authority.
7. An Applicant shall provide any other such documentary evidence of eligibility satisfactory to the Procuring Entity, as the Procuring Entity shall reasonably request.
8. An Applicant requiring any clarification of the Registration Document shall contact the Procuring Entity in writing through the email info@fundifix.org . The Procuring Entity will respond in writing to any request for clarification provided that such request is received no later than five (5) days prior to the deadline for submission of the applications.
9. The Applicant shall bear all costs associated with the preparation and submission of its Application. The Procuring Entity will in no case be responsible or liable for those costs,

regardless of the conduct or outcome of the Registration process.

10. The Applicant shall complete an Application Submission Letter as provided in Section IV (Application Forms). This Letter must be completed without any alteration to its format.
11. All information provided by the Applicant pursuant to these requirements must be complete, current and accurate as at the date of provision to the Procuring Entity. In submitting the information required pursuant to these requirements, the Applicant shall warrant that the information submitted is complete, current and accurate as at the date of submission to the Procuring Entity.
12. The Procuring Entity may, at its discretion, extend the deadline for the submission of Applications by amending the Registration Document.
13. The Procuring Entity shall prepare a record of the opening of Applications to include, as a minimum, the name of the Applicants.
14. Information relating to the Applications, their evaluation and results of the Registration shall not be disclosed to Applicants, or any other persons not officially concerned with the Registration process until the notification of Registration results is made to all Applicants.
15. To assist in the evaluation of Applications, the Procuring Entity may, at its discretion, ask an Applicant for a clarification (including missing documents) of its application, to be submitted within a stated reasonable period of time. Any request for clarification from the Procuring Entity and all clarifications from the Applicant shall be in writing.
16. If an Applicant does not provide clarifications and/or documents requested by the date and time set in the Procuring Entity's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.
17. The Procuring Entity may reject any Application which is not responsive to the requirements of the Registration Document. In case the information furnished by the Applicant is incomplete or otherwise requires clarification, and the Applicant fails to provide satisfactory clarification and/or missing information, it may result in disqualification of the Applicant.
18. The Procuring Entity shall use the factors, methods, criteria, and requirements defined in Section III, Qualification Criteria and Requirements, to evaluate the qualifications of the Applicants, and no other methods, criteria, or requirements shall be used. The Procuring Entity reserves the right to waive min or deviations from the qualification criteria if they do not materially affect the technical capability and financial resources of an Applicant to perform the Contract.
19. All Applicants whose applications substantially meet or exceed the specified qualification requirements will be prequalified by the Procuring Entity. The Procuring Entity shall notify all Applicants in writing of the names of those Applicants who have been prequalified or conditionally prequalified. In addition, those Applicants who have been disqualified will be informed separately.
20. As needed over the period 2024-2026, the Procuring Entity shall invite Tenders from all the Applicants that have been prequalified or conditionally prequalified. Applicants may be required to provide a Tender Security or a Tender-Securing Declaration acceptable to the Procuring Entity in the form and an amount to be specified in the tendering document.
